## Holliday, Case and Selck are Victors Tuesday

Democratic Candidate For Collector Defeats Jess Hays By Only 48 Votes

REPUBLICANS POLL 2381, DEMOCRATS 1461

Selck Shows Strength With Margin of 940 Over H. L. Day; Lymer Loses by 35

Although there was apparently very little interest in the primary election held in Cooper County Tuesday, the unofficial count from the thirty voting precincts of the county showed a total of 3,842 votes cast. 2381 Republicans and 1461 Democrats registering their preference for the various candidates. This was 726 more votes than were polled in the primary election two years ago; which preceded a presidential contest in which 9,157 votes were cast.

Interest in Tuesday's election centered around the races for collector of the county's revenue, which is the most lucrative position in the court house. It pays the incumbent between \$6,000 and \$7,000 annually, but out of this return he must provide his own

On the Republican ticket Hillard Selck, present deputy under Collector O. J. Schlotzhauer far outdistanced his two opponents, H. L. Day of Blackwater, and Fred Oerly, of Pilot Grove. Selck received, according to the unofficial count, 1463 votes, Day 543, and Oerly 289. Thus it will be seen that Selck's majority is 940.

On the Democratic ticket it was a "horse race" between E. C. Holliday, of Boonville, and J. T. Hays, of Bunceton, Holliday winning out by an unofficial count of

The only other contest on either county ticket was that for judge of the Western District, H. D. Case, of Otterville, a former judge of the district, and Melvin Lymer, a young farmer of near Blackwater, contending for the Republican nomination. Case received 742 votes, compared to Lymer's 707, according to the unofficial count.
