

Howard Co. Man Shot Resisting Arrest

**A. L. McClellan Hit in Hip When
He Runs From Sheriff
Wells**

A. L. (Buster) McClellan of Howard County is confined to his home following a gunshot wound suffered when he was shot in the hip by Sheriff Wells Sunday night following a raid made on the Bert Leaveworth place. McClellan and David and Benny Lancaster, all of South Howard County, were caught by Deputy Sheriff Ray and Sheriff Wells near a cache of liquor. They were ordered to halt by the officers when they approached the liquor, and instead they ran. Sheriff Wells fired, and McClellan was struck.

McClellan was taken to his home where he was arrested, but has not been moved because of his wound. The other men are wanted. The officers found 20 gallons of liquor in the cache.

Boonville Babies at Fair Win Awards

Dr. and Mrs. A. P. Wolf received word from officials of the Missouri State Fair baby contest that their son, Jack Moseley Wolf, three and one-half years old, made a score of 96.5 percent perfect. Deductions were made because the child had not been administered a preventative against diphtheria and small pox and refused a number of foods necessary to proper diet. His physical condition was adjudged practically perfect.

Walter William, son of Mr. and Mrs. John Esser, also made a high scoring of 97 at this contest, and was not considered a blue ribbon baby because he did not receive vaccination for small pox and diphtheria. Another son of Mr. and Mrs. Esser, Francis Martin, entered the nine point contest, and because of not being vaccinated, received only a six point button.

Hubert Frank, Jr., two-year-old son of Mr. and Mrs. Hubert Heyling, was Boonville's only blue ribbon baby this year. He is one of the few babies eligible to receive the Governor's cup awarded the best blue ribbon baby in the state.

OTTERVILLE AND PILOT GROVE BOYS ARRESTED

John Lee Reed, 18, of Otterville, and William Pulley, 24, of Pilot Grove, charged with breaking into two stores in Otterville, waived preliminary hearing before Judge Whurley's court at Otterville and were bound over to circuit court.

Reed lives with his father at Otterville, and confessed that he entered Burnett's restaurant through a window that he had removed, about two o'clock in the morning around the first of May. He said he took a large supply of candy, cigars, cigarettes, food and other things which he hid in the weeds near his home. He also stated that William Pulley entered the Brisley store in Otterville about the first of June at two o'clock in the morning and took some clothing, groceries, candy and tobacco.

Following these thefts, they went to Kansas where they worked in the harvest fields and they were held on charges upon their arrival here.
