

## MRS. L. O. NELSON DIES SUNDAY

Former Cooper County Citizen Passes Away At Home Of Sister; Services Here.

Mrs. Nancy Lacy Nelson, wife of Louis O. Nelson, formerly of Cooper County, died early Sunday morning at the home of her sister, Mrs. E. E. Amick, 5411 Baltimore, Kansas City, after a brief illness. She was 55 years old.

Funeral services were held at the Edgar C. Nelson home in Boonville at 2 o'clock this afternoon, conducted by Rev. T. M. MacDonnell, Mrs. Nelson's former pastor at Bunceton. Interment was in the Bunceton cemetery.

Nancy Lacy Jones was born Jan. 25, 1875, near Prairie Home. On Aug. 16, 1900, she was married to Louis O. Nelson, Bunceton newspaperman and widely known in this county. To this union four children were born, one of whom died in infancy. She is survived by her husband, Mr. Nelson, two sons, Louis, Jr., and William, the latter a student in Missouri University, a daughter, Nancy Lee, her mother, Mrs. Gilbert F. Jones, three brothers, L. F. Jones, Comanche, Okla., D. W. Jones, Clovis, N. M., and R. L. Jones, Rich Hill, Mo., and three sisters, Mrs. E. E. Amick, Kansas City, Mrs. E. F. Reavis, Bunceton, and Mrs. C. D. Wells, Tonganoxie, Kans.

Mrs. Nelson lived the greater part of her life in Cooper County in the Bunceton community. She joined the Baptist church at an early age and was a constant worker therein. She was educated in the public schools of her home community and at Hardin College, Mexico, Mo. Several years ago the family moved to Rich Hill, leaving a host of friends in Cooper county.

Pallbearers at the funeral were Charles Friday, H. L. Shirley, Ed Harned, John Windsor, Adolph Victor, and Roy D. Williams.

The song service at the rites this afternoon was conducted by A. Tearle, Boonville. Many friends and relatives, and beautiful floral offerings, at the services attested the esteem in which this kind woman was held. She was a loving mother and wife, leaving enduring friendships and good deeds done after her.
