S. S. CASE, VETERA N OF CIVIL WAR, DIES

Funeral of Aged Man to Be Held Tomorrow.

At the age of 85 years, Samuel S. Case, for about 62 years a resident of Hannibal and vicinity, passed away at 6:15 o'clock Sunday, evening, in his home, 3107 Market street. He had been ill since Dec. 22.

A native of Wisconsin. Mr. Case was born at Monroe, Jan. 19, 1847. During the Civil war he served with the Union army in Company A., 46th Division of the Wisconsin infantry, and was honorably discharged from service on Sept. 27, 1865, at Nashville, Tenn. Following his discharge from service in 1865, he came to Missouri and settled in Cooper county. where he resided for four years or more, and about 1870, removed to this vicinity. For a number of years, he operated a general store at Hydesburg, later engaging in farming in that vicinity, and then removed to Oakwood, where he lived for several years and then engaged in farming in Marion county for some time. He disposed of his farming interests and located at Oakwood, in the home where he passed away yester-day. Mr. Case was twice married, his first wife being Miss Mary Frances Herring, a member of an old Ralls county family, who passed away March 25, 1922. Two and a half years ago, Mr. Case married Mrs. Emma Peyton, who survives.
