# Wrangling begins over gas tax hike

WASHINGTON (AP) - The Reagan administration, seeking votes for its proposed gasoline tax increase, is trying to accommodate members of Congress who want to bend parts of the plan to protect pet projects.

The 5-cent-a-gallon hike in the federal gasoline tax has strong bipartisan support. But wrangling over the plan - aimed at financing \$5.5 billion worth of highway, bridge and mass transit repairs - is picking up with legislative action beginning today in the House Ways and Means Committee.

"A lot of heavyweights have a lot of parochial interests in this," said an aide to a congressional leader.

Transportation Secretary Drew Lewis said at congressional hearings this week that up to 13 states might be unable to pay the matching share - averaging 17 percent - required in-federallyaided construction projects. That could make it impossible for those states to grant contracts for the repair work.

Meanwhile, other tornadoes and damaging thunderstorms that swept across Missouri Wednesday night and early today have injured at least 20 people and damaged scores of houses and farm buildings, police

High winds and rain roared through Henry, Johnson and Saline counties, flooding some low-lying areas, city streets and basements. More than 2 inches of rain fell in 15 minutes in some areas of Saline County, the National Weather Service said.

Heavy rain and street flooding caused damage in some areas of the state. Warrensburg received more than 41/2 inches of rain, while Boonville and Nevada received nearly 4 inches. More than 2 inches of rain fell in a short period in some areas.

Nine people were injured before dawn when a storm struck at Mountain Grove in south-central Missouri, where 25 to 30 homes

were damaged or destroyed. Police Chief Bert Hopkins said most of the damage was outside the city, where roofs were blown off houses and windows were blown out. Hopkins said no one spotted a tornado but noted that the storm struck during the early morning hours.

"It just kind of slipped in. Nobody expected

it,'' Hopkins said. Three more people were injured before dawn when the storm roared through a rural area of east-central Missouri between Japan
