He had been a class mate of Stanley's in Great Lakes Naval Training Station and had been transferred to Rhode Island in the same squadron with Stanley.

At three o'clock Friday afternfoon funeral services for Stanley and memorial services for Lieut. Spiers, whose body was never recovered, were held at the Navy auditorium in Rhode Island. After these services 15 plane squadrons took off and each dropped a wreath where the crash occurred.

o: B. Surber dies in Chiokasha, oklahoma

The first big oil stalks in southwestern Oldahoma was **made** on the O.B. Surber farm, who died at his home in this city Monday night. The farm on which the black gold was found was a poor upland farm about six miles southwest of Duncan. Surber leased the land to the Empire Fuel Co., who put down the first well in 1929, Surber was mixing mortar and working on a building in Duncan when the news flashed that oil had --- n struck on the Surber place, Surber redused to be disturbed by the report and kept on mixing mortar until the day's work was done. The first well was a 750 barrel well and 30 producers were drilled on the land and the wells are all still producing oil and it is said that there is considerable inside stuff on the farm yet to be drilled.

Sumber from a poor upland farmer became one of the richest men in Stephens county over night. He paid income taxes the first year after the oil strike on an income of \$150,000. The oil sand on his land produced from three levels and are still pouring out the black gold. Surber after the striking of oil was attracted to Chickasha and invested practically all of his wealth in Chickasha real estate and Grady county farms. At his death he owned a number of valuable down town real estate buildings but had sold or practically all his Grady county farm land. He owned at his death the building where the Motor Equipment is located, the building where Roe's hamburger shop is located, the building where Lacy's bakery was located, the building where Baker's Plumbing Shop is located and several buildings just north of the Grand Flling Station.

The death of Surber was sudden. Last Friday afternoon he was visiting at the Grand Filling Station, talking with the station attendants when he suddenly felt a sharp pain in his side. The pain grew in inpensity until late that night he was taken to the Chickasha hospital and operated upon for appendicitis. A badly inflamed condition of the appendix was found and his recovery was retarded by a diabetis condition. He failed to rally as he should have from the operation and his death occurred at 12 o'clock Tuesday night.

His funeral was held from the Methodist church at 10 o'clock Thursday. The Rev. Armstrong in charge. Surber was a devoted and faithful member of the Methodist church and was seldom absent from his place in the church at the Sunday morning services. He was a liberal contributor to every civic enterprise for the betterment of his city.

Surviving members of the family include his widow; two sons, Frank Benton and William J. Surber; one sister, Mrs. Mollie Clark of Tuksa. Two brothers, Warren Surber of Columbia, Mo., and Newt Surber of Clarence, Mo., 10 grandchildren and one great grandchild.
