MRS. CHAMP CLARK DIES 1946

New Orleans, La., June 10.—Mrs. Champ Clark, 82, widow of the late famous Democratic Speaker of the National House of Representatives, died here today at 9:00 o'clock after a long illness at the residence of her daughter, Mrs. James M. Thomson.

Her husband died March 2, 1921, just prior to the inauguration of President Harding. Until that year Mrs. Clark lived in Washington during the 28 years her husband was a member of the House of Representatives, and took public interest in the cause of peace and women's suffrage.

Mrs. Clark was a pioneer in the suffrage movement and joined her husband in the study of subjects connected with American history.

Champ Clark was Speaker of the House for two years prior to, and for six years during the administration of President Wilson. At the time of his death he was minority leader of the Democratic party in the House.

Mrs. Clark was born before the war between the states as Genevieve Davis Bennett, on a farm near New Bloomfield, Callaway county, Missouri.

She was the youngest of seven brothers and sisters, children of Mary McAfee, a member of a pioneer Virginia family, and Joel D. Bennett of Madison county, Ky., a descendant of a pioneer Maryland family.

She was one of the first students to enter the University of Missouri.

After Champ Clark's death, Mrs. Clark resided at Bowling Green, Mo., usually during the summer and visited her daughter, Mrs. Thomson, in New Orleans, during the winter months. In recent years due to her failing health, she had spent her time largely at Mrs. Thomson's home.

Mrs. Clark is survived by two children, Bennett Champ Clark, now U. S. Senator from Missouri, and Mrs. Thomson, wife of the publisher of the New Orleans Item-Tribune.

She is also survived by a brother, George Bennett, and a sister, Mrs. Mary E. Herndon, of Fulton, Mo.
